## DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 16-18-2-123.1; IC 16-42-5.5.

**Synopsis:** Health standards for farmers' markets. Requires the state department of health to adopt rules to establish guidelines concerning health and sanitary standards for food sold at farmers' markets and roadside stands. Prohibits a city, town, or county from adopting an ordinance concerning health and sanitary standards for food sold at farmers' markets.

**Effective:** July 1, 2013.

# SENATE BILL No. 411



A BILL FOR AN ACT to amend the Indiana Code concerning health.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 16-18-2-123.1 IS ADDED TO THE INDIANA  
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS  
3 [EFFECTIVE JULY 1, 2013]: **Sec. 123.1. "Farmers' market", for**  
4 **purposes of IC 16-42-5.5, has the meaning set forth in**  
5 **IC 16-42-5.5-1.**

6 SECTION 2. IC 16-42-5.5 IS ADDED TO THE INDIANA CODE  
7 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE  
8 JULY 1, 2013]:

9 **Chapter 5.5. Farmers' Markets**  
10 **Sec. 1. As used in this chapter, "farmers' market" means a**  
11 **common indoor or outdoor area where two (2) or more farmers,**  
12 **growers, or producers gather on a regular basis to sell directly to**  
13 **consumers farm or locally grown products that they grow or**  
14 **produce.**

15 **Sec. 2. Subject to IC 16-42-5-29, the state department shall**  
16 **adopt rules under IC 4-22-2 to establish guidelines concerning**  
17 **health and sanitary standards for food sold at farmers' markets**



1 **and roadside stands.**  
2 **Sec. 3. A city, town, or county may not adopt an ordinance**  
3 **concerning health and sanitary standards for food sold at farmers'**  
4 **markets and roadside stands.**
