DIGEST OF INTRODUCED BILL

Citations Affected: IC 20-30-5-13.

Synopsis: Medically accurate sex education. Requires instruction in public schools and accredited nonpublic schools on human sexuality or sexually transmitted diseases to be based on information that is factual, medically accurate, and age appropriate.

Effective: July 1, 2013.

SENATE BILL No. 454



A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 20-30-5-13, AS ADDED BY P.L.1-2005,
- 2 SECTION 14, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 3 JULY 1, 2013]: Sec. 13. (a) **As used in this section, "appropriate**
- 4 **instructor" means an instructor with knowledge of the most recent**
- 5 **medically accurate research on human sexuality, pregnancy, and**
- 6 **sexually transmitted diseases.**
- 7 (b) **As used in this section, "comprehensive sexual health**
- 8 **education" means education regarding human development and**
- 9 **sexuality, including education on pregnancy, family planning, and**
- 10 **sexually transmitted diseases, as well as healthy relationships and**
- 11 **healthy communication skills.**
- 12 (c) **As used in this section, "factual information" includes but is**
- 13 **not limited to medical, psychiatric, psychological, empirical, and**
- 14 **statistical statements.**
- 15 (d) **As used in this section, "instructor" means an employee,**
- 16 **contractor, or consultant of the school district.**
- 17 (e) **As used in this section, "medically accurate" refers to**



1 **information that is supported by the weight of research conducted**
 2 **in compliance with accepted scientific methods and recognized as**
 3 **accurate and objective by leading professional organizations and**
 4 **agencies with relevant expertise in the field.**

5 **(f) Throughout If an accredited school provides** instruction on
 6 human sexuality or sexually transmitted diseases, **an the** accredited
 7 school shall

8 (1) require a teacher to teach abstinence from sexual activity
 9 outside of marriage as the expected standard for all school age
 10 children;

11 (2) include in the instruction that abstinence from sexual activity
 12 is the only certain way to avoid out-of-wedlock pregnancy;
 13 sexually transmitted diseases; and other associated health
 14 problems; and

15 (3) include in the instruction that the best way to avoid sexually
 16 transmitted diseases and other associated health problems is to
 17 establish a mutually faithful monogamous relationship in the
 18 context of marriage: **provide comprehensive sexual health**
 19 **education for any grade level, using appropriate instructors.**

20 **(g) Instruction and materials used in comprehensive sexual**
 21 **health education under this section shall satisfy all of the following**
 22 **criteria:**

23 **(1) Be age appropriate.**

24 **(2) Be medically accurate.**

25 **(3) Be appropriate for use with pupils of all races, genders,**
 26 **sexual orientations, and ethnic and cultural backgrounds, and**
 27 **pupils with disabilities.**

28 **(4) Encourage pupils to communicate with the pupils' parents**
 29 **about human sexuality.**

30 **(5) Teach respect for marriage and committed relationships.**

31 **(6) Teach that abstinence from sexual intercourse is the only**
 32 **certain way to prevent unintended pregnancy and sexually**
 33 **transmitted diseases.**

34 **(7) Provide information about the effectiveness and safety,**
 35 **including the health benefits and side effects, of all**
 36 **contraceptive methods in preventing pregnancy and reducing**
 37 **the risk of contracting sexually transmitted diseases.**

38 **(8) Provide pupils with skills for negotiating intimate**
 39 **relationships and making and implementing responsible**
 40 **decisions about sexuality.**

41 **(9) Be appropriate for pupils who choose to be abstinent and**
 42 **for those who have been or are sexually active.**

(h) Comprehensive sexual health education provided under this section shall not include any instruction or materials that do either of the following:

- (1) Teach or promote religious doctrine.**
- (2) Reflect or promote bias against any person on the basis of race, color, religion, gender, familial status, sexual orientation, disability, or national origin.**

(i) If an accredited school provides comprehensive sexual health education under this section:

- (1) school officials shall notify parents that parents have the right to review the curriculum in its entirety and that written and audiovisual educational materials used in the education are available for inspection; and**
- (2) parents have the right to excuse their child from all or parts of the instruction, and must be provided notice of the right.**
