DIGEST OF INTRODUCED BILL

Citations Affected: IC 5-22-17-5.5.

Synopsis: State money to entities performing abortions. Repeals provisions prohibiting state grants to or contracts with any entity that performs abortions or maintains or operates a facility where abortions are performed.

Effective: July 1, 2013.

A BILL FOR AN ACT to repeal a provision of the Indiana Code concerning state and local administration.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 5-22-17-5.5 IS REPEALED [EFFECTIVE JULY
2 1, 2013]. ~~Sec. 5.5: (a) This section does not apply to hospitals licensed~~
