DIGEST OF INTRODUCED BILL

Citations Affected: IC 12-7-2-32.5; IC 12-15-36.

Synopsis: Medicaid payments for children's nursing facilities. Requires the office of Medicaid policy and planning to reimburse children's nursing facilities in accordance with Medicare payment principles.

Effective: July 1, 2013.

SENATE BILL No. 516



A BILL FOR AN ACT to amend the Indiana Code concerning Medicaid.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 12-7-2-32.5 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2013]: **Sec. 32.5. "Children's nursing facility", for purposes of**
4 **IC 12-15-36, has the meaning set forth in IC 12-15-36-1.5.**

5 SECTION 2. IC 12-15-36-1.5 IS ADDED TO THE INDIANA
6 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
7 [EFFECTIVE JULY 1, 2013]: **Sec. 1.5. As used in this chapter,**
8 **"children's nursing facility" means a nursing facility that has:**
9 (1) **fifteen percent (15%) or more of its residents who are less**
10 **than twenty-one (21) years of age; and**
11 (2) **received written approval from the office to be designated**
12 **as a children's nursing facility.**

13 SECTION 3. IC 12-15-36-8 IS ADDED TO THE INDIANA CODE
14 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
15 1, 2013]: **Sec. 8. The office shall reimburse a children's nursing**
16 **facility in accordance with Medicare payment principles.**
