
HOUSE BILL No. 1098

DIGEST OF INTRODUCED BILL

Citations Affected: IC 27-7-5.1; IC 34-6-2; IC 34-30-27.

Synopsis: Noneconomic damages for uninsured motorists. Specifies that an insurer may not pay noneconomic damages on a motor vehicle insurance claim for a loss incurred by an uninsured motorist at least 18 years of age. Provides that a person who sustained bodily injury or property damage as the result of a motor vehicle accident but who was an uninsured motorist at the time of the accident may not recover noneconomic damages for the person's bodily injury or property damage from another person who was operating another motor vehicle when that other motor vehicle was involved in the accident unless a person other than the uninsured motorist is convicted of a crime in connection with the accident.

A BILL FOR AN ACT to amend the Indiana Code concerning insurance.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 27-7-5.1 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2013]:

4 **Chapter 5.1. Miscellaneous Motor Vehicle Insurance Provisions**

5 **Sec. 1. As used in this chapter, "financial responsibility" means**
6 **the ability to respond in damages as described in IC 9-25-2-3.**

7 **Sec. 2. As used in this chapter, "motor vehicle insurance policy"**
8 **means a policy that provides the kind of coverage described in**
9 **Class 2(f) of IC 27-1-5-1.**

10 **Sec. 3. (a) As used in this chapter, "noneconomic damages"**
11 **means costs for the following:**

- 12 (1) **Physical and emotional pain and suffering.**
- 13 (2) **Physical impairment.**
- 14 (3) **Emotional distress.**
- 15 (4) **Mental anguish.**
- 16 (5) **Disfigurement.**
- 17 (6) **Loss of enjoyment.**



- 1 (7) **Loss of companionship, services, and consortium.**
- 2 (8) **Any other nonpecuniary loss proximately caused by a**
- 3 **motor vehicle accident.**
- 4 **(b) The term does not include costs for the following:**
- 5 (1) **Treatment and rehabilitation.**

14 **Sec. 4. As used in this chapter, "uninsured motorist" means the**
 15 **owner of a motor vehicle for which financial responsibility is not**
 16 **in effect as required by IC 9-25-4, regardless of whether the owner**
 17 **is operating the motor vehicle at the time of an accident.**

18 **Sec. 5. An insurer may not pay noneconomic damages on a**
 19 **claim for coverage under a motor vehicle insurance policy issued**
 20 **by the insurer if the claim is for coverage for a loss incurred by an**
 21 **uninsured motorist.**

22 **Sec. 6. (a) Section 5 of this chapter does not apply to a claim for**
 23 **coverage for a loss incurred by an uninsured motorist who is less**
 24 **than eighteen (18) years of age.**

25 **(b) Section 5 of this chapter does not apply if a person other**
 26 **than the uninsured motorist:**

- 27 **(1) operates a motor vehicle involved in the accident; and**
- 28 **(2) is convicted of a crime in connection with the accident.**

29 **SECTION 2. IC 34-6-2-84 IS AMENDED TO READ AS**

 36 **IC 34-30-27, has the meaning set forth in IC 34-30-27-2.**

 38 **CODE AS A NEW SECTION TO READ AS FOLLOWS**
 39 **[EFFECTIVE JULY 1, 2013]: Sec. 144.8. "Uninsured motorist", for**
 40 **purposes of IC 34-30-27, has the meaning set forth in IC 27-7-5.1-4.**

3 **may not recover noneconomic damages under IC 34-23-1 for the**
4 **person's death from another person who was operating another**
5 **motor vehicle when that other motor vehicle was involved in the**

7 **Sec. 4. (a) Section 3(a) of this chapter does not apply to a person**
8 **who was less than eighteen (18) years of age at the time of the**

12 **age at the time of the motor vehicle accident.**
