

SENATE MOTION

MADAM PRESIDENT:

I move that Senate Bill 528 be amended to read as follows:

- 1 Page 21, line 26, after "chapter" insert "**before July 1, 2014,**".
- 2 Page 21, line 27, after "(e)." insert "**The first five and one-tenth**
- 3 **percent (5.1%) of tax revenues collected under this chapter in each**
- 4 **state fiscal year beginning after June 30, 2014, shall be set aside for**
- 5 **revenue sharing under subsection (e)."**
- 6 Page 27, line 34, after "remitted" insert "**before July 1, 2014,**".
- 7 Page 28, between lines 12 and 13, begin a new paragraph and insert:
- 8 "**(c) Subject to section 12 of this chapter, the treasurer of state**
- 9 **shall quarterly pay the following amounts of the supplemental**
- 10 **wagering tax remitted after June 30, 2014, by a licensed owner:**
- 11 (1) **Thirty-seven and fifty-five hundredths percent (37.55%)**
- 12 **to the city in which the riverboat is located if the city is**
- 13 **located in Dearborn County, LaPorte County, Ohio County,**
- 14 **or Vanderburgh County.**
- 15 (2) **Thirty-seven and fifty-five hundredths percent (37.55%)**
- 16 **to the county in which the riverboat is located.**
- 17 (3) **This subdivision applies only to a riverboat that is located**
- 18 **in Harrison County or Switzerland County. Thirty-seven and**
- 19 **fifty-five hundredths percent (37.55%) to the county in which**
- 20 **the riverboat is located. Amounts paid to the county under**
- 21 **this subdivision are in addition to the amounts paid under**
- 22 **subdivision (2).**
- 23 (4) **Three and seventy-six hundredths percent (3.76%) to the**
- 24 **county convention and visitors bureau or promotion fund for**
- 25 **the county in which the riverboat is located.**
- 26 (5) **Five and sixty-three hundredths percent (5.63%) to the**
- 27 **state fair commission.**
- 28 (6) **Three and seventy-six hundredths percent (3.76%) to the**
- 29 **division of mental health and addiction.**
- 30 (7) **Eleven and seventy-five hundredths percent (11.75%) to**

1 **the state general fund."**
2 Page 28, line 17, after "remitted" insert "**before July 1, 2014,**".
3 Page 28, between lines 30 and 31, begin a new paragraph and insert:
4 "**(c) Subject to section 12 of this chapter and IC 6-3.1-20-7, the**
5 **treasurer of state shall quarterly pay the following amounts of the**
6 **supplemental wagering tax remitted after June 30, 2014, by a**
7 **licensed owner:**
8 **(1) Thirty-seven and fifty-five hundredths percent (37.55%)**
9 **to the city in which the riverboat is located.**
10 **(2) Thirty-seven and fifty-five hundredths percent (37.55%)**
11 **to the county.**
12 **(3) Three and thirty-eight hundredths percent (3.38%) to the**
13 **county convention and visitors bureau or promotion fund.**
14 **(4) Thirty-eight hundredths percent (0.38%) to the northwest**
15 **Indiana law enforcement training center.**
16 **(5) Five and sixty-three hundredths percent (5.63%) to the**
17 **state fair commission.**
18 **(6) Three and seventy-six hundredths percent (3.76%) to the**
19 **division of mental health and addiction.**
20 **(7) Eleven and seventy-five hundredths percent (11.75%) to**
21 **the state general fund."**
