

SENATE MOTION

MADAM PRESIDENT:

I move that Senate Bill 535 be amended to read as follows:

- 1 Page 4, line 1, after "by" insert "**both:**
2 **(1)**".
3 Page 4, line 2, after "IC 6-1.1-17-20" delete "." and insert "; **and**
4 **(2) the county executive of Clark County.**".
5 Page 4, line 5, after "of" insert "**both:**
6 **(1)**".
7 Page 4, line 6, after "IC 6-1.1-17-20.5" delete "." and insert "; **and**
8 **(2) the county executive of Clark County.**".
9 Page 6, delete lines 36 through 40, begin a new line block indented
10 and insert:
11 "**(28) Provide revenue (including property tax proceeds**
12 **allocated under section 39 of this chapter) to an airport**
13 **authority located in whole or in part in the same county as the**
14 **commission, if:**
15 **(A) the commission by resolution makes a determination**
16 **that providing the revenue will enhance economic**
17 **development opportunities; and**
18 **(B) the fiscal body of the unit that established the**
19 **commission adopts a resolution that approves the**
20 **providing of the revenue to the airport authority.**".
21 Page 12, delete lines 20 through 23, begin a new line double block
22 indented and insert:
23 "**(M) Provide revenue to an airport authority located in**
24 **whole or in part in the same county as the commission, if:**
25 **(i) the commission has adopted a resolution under**
26 **section 12.2(a)(28) of this chapter determining that**
27 **providing the revenue will enhance economic**
28 **development opportunities; and**
29 **(ii) the fiscal body of the unit that established the**
30 **commission adopts a resolution that approves the**

1 **providing of the revenue to the airport authority."**
 2 Page 17, delete line 42, begin a new line block indented and insert:
 3 **"(21) Provide revenue (including property tax proceeds**
 4 **allocated under section 26 of this chapter) to an airport**
 5 **authority located in whole or in part in the same county as the**
 6 **commission, if:**
 7 **(A) the commission by resolution makes a determination**
 8 **that providing the revenue will enhance economic**
 9 **development opportunities; and**
 10 **(B) the fiscal body of the unit that established the**
 11 **commission adopts a resolution that approves the**
 12 **providing of the revenue to the airport authority."**

13 Page 18, delete lines 1 through 4.

14 Page 23, delete lines 29 through 32, begin a new line double block
 15 indented and insert:

16 **"(K) Provide revenue to an airport authority located in**
 17 **whole or in part in the same county as the commission, if:**
 18 **(i) the commission has adopted a resolution under**
 19 **section 7(a)(21) of this chapter determining that**
 20 **providing the revenue will enhance economic**
 21 **development opportunities; and**
 22 **(ii) the fiscal body of the unit that established the**
 23 **commission adopts a resolution that approves the**
 24 **providing of the revenue to the airport authority."**

25 Page 28, delete lines 38 through 42, begin a new line block indented
 26 and insert:

27 **"(26) Provide revenue (including property tax proceeds**
 28 **allocated under section 25 of this chapter) to an airport**
 29 **authority located in whole or in part in the same county as the**
 30 **reuse authority, if:**
 31 **(A) the reuse authority by resolution makes a**
 32 **determination that providing the revenue will enhance**
 33 **economic development opportunities; and**
 34 **(B) the fiscal body of the unit that established the reuse**
 35 **authority adopts a resolution that approves the providing**
 36 **of the revenue to the airport authority."**

37 Page 29, between lines 3 and 4, begin a new paragraph and insert:

38 **"(c) In addition to the requirements under subsection (a)(26), a**
 39 **reuse authority located in Clark County may not transfer any**
 40 **funds to an airport authority unless the reuse authority has entered**
 41 **into an interlocal cooperation agreement with all of the following,**
 42 **in which all of the following have approved the transfer of the**
 43 **funds:**
 44 **(1) The city of Jeffersonville.**
 45 **(2) The city of Charlestown.**
 46 **(3) The town of Utica.**

(4) The town of Clarksville."

Page 31, delete lines 21 through 24, begin a new line double block indented and insert:

"(G) Provide revenue to an airport authority located in whole or in part in the same county as the reuse authority, if:

(i) the reuse authority has adopted a resolution under section 9(a)(26) of this chapter determining that providing the revenue will enhance economic development opportunities; and

(ii) the fiscal body of the unit that established the reuse authority adopts a resolution that approves the providing of the revenue to the airport authority."

Page 34, between lines 1 and 2, begin a new paragraph and insert:

"(i) In addition to the requirements under subsection (b)(3)(G), a reuse authority located in Clark County may not transfer any funds to an airport authority unless the reuse authority has entered into an interlocal cooperation agreement with all of the following, in which all of the following have approved the transfer of the funds:

(1) The city of Jeffersonville.

(2) The city of Charlestown.

(3) The town of Utica.

(4) The town of Clarksville."
