

SENATE MOTION

MADAM PRESIDENT:

I move that Engrossed House Bill 1311 be amended to read as follows:

- 1 Page 7, delete lines 6 through 14, begin a new paragraph and insert:
- 2 "SECTION 14. IC 3-11-1.5-10.7 IS ADDED TO THE INDIANA
- 3 CODE AS A NEW SECTION TO READ AS FOLLOWS
- 4 [EFFECTIVE JULY 1, 2013]: **Sec. 10.7. If a conflict exists between**
- 5 **the map of a precinct and the description of the boundaries of a**
- 6 **precinct submitted by a county and approved under this chapter,**
- 7 **the precinct boundary is the description of the boundaries of the**
- 8 **precinct, rather than the map of the precinct, to the extent of any**
- 9 **conflict between the map and the description."**
- 10 Page 13, delete lines 40 through 42, begin a new paragraph and
- 11 insert:
- 12 **"(l) If the voter indicates that the voter resides at an address**
- 13 **that is within the same precinct, or makes an affirmation of this**
- 14 **change of address under IC 3-7-39-7, the county election board**
- 15 **shall direct the county voter registration office to transfer the**
- 16 **voter's voter registration to the address within the precinct**
- 17 **indicated by the voter.**
- 18 **(m) If the voter indicates that the voter's current residence is**
- 19 **located within another county in Indiana, the voter is considered**
- 20 **to have directed the county voter registration office of the county**
- 21 **where the precinct is located to cancel the voter registration record**
- 22 **within the county. The precinct election board shall provide the**
- 23 **voter with a voter registration application for the voter to complete**
- 24 **and file with the county voter registration office of the county**
- 25 **where the voter's current residence address is located.**
- 26 **(n) If the voter indicates that the voter's current residence is**
- 27 **located outside Indiana, the voter is considered to have directed the**
- 28 **county voter registration office of the county where the precinct is**
- 29 **located to cancel the voter registration record within the county."**
- 30 Page 14, delete lines 1 through 6.

- 1 Page 17, line 6, after "negligently" insert "**markets,**".
- 2 Page 30, line 6, strike "before the election" and insert "**not later**
- 3 **than December 31 of the year**".
- 4 Page 30, line 7, strike "effective date of the subsequent" and insert
- 5 "**year in which a**".
- 6 Page 30, line 7, after "census" insert "**is taken**".
- 7 Page 30, line 8, strike "by resolution".
- 8 Renumber all SECTIONS consecutively.
