

# SENATE MOTION

**MADAM PRESIDENT:**

**I move** that Engrossed House Bill 1357 be amended to read as follows:

- 1 Page 2, line 12, delete "not".
- 2 Page 2, line 12, after "hold" insert "**either**".
- 3 Page 2, line 13, delete "." and insert "**or a temporary**
- 4 **superintendent's license under IC 20-28-8-5.5**".
- 5 Page 5, line 39, delete "not".
- 6 Page 5, line 39, after "hold" insert "**either**".
- 7 Page 5, line 39, delete "IC 20-28-5)," and insert "**IC 20-28-5 or a**
- 8 **temporary superintendent's license under IC 20-28-8-5.5)**".
- 9 Page 9, between lines 15 and 16, begin a new paragraph and insert:
- 10 "SECTION 6. IC 20-28-8-5.5 IS ADDED TO THE INDIANA
- 11 CODE AS A **NEW SECTION TO READ AS FOLLOWS**
- 12 [EFFECTIVE JULY 1, 2013]: **Sec. 5.5. (a) This section applies**
- 13 **whenever a governing body wishes to employ as a superintendent**
- 14 **an individual who does not hold a license under IC 20-28-5.**
- 15 **(b) An individual described in subsection (a) shall be granted a**
- 16 **temporary superintendent's license if the following requirements**
- 17 **are met:**
- 18 **(1) The governing body submits a written request to the state**
- 19 **superintendent for a temporary superintendent's license on**
- 20 **behalf of the individual. The written request must include the**
- 21 **following:**
- 22 **(A) A description of the content area for the license of**
- 23 **"district level administrator: superintendent".**
- 24 **(B) Documentation of the individual's applicable**
- 25 **knowledge or experience.**
- 26 **(C) Documentation that the individual has obtained a**
- 27 **master's degree or higher degree from an accredited**
- 28 **postsecondary educational institution.**
- 29 **(2) The temporary superintendent's license approval**
- 30 **committee established by subsection (c) approves the written**

- 1           request by a majority vote.
- 2           **(c) The temporary superintendent's license approval committee**
- 3 **is established. The committee consists of five (5) members,**
- 4 **including the state superintendent. The state superintendent shall**
- 5 **appoint the remaining four (4) members, including the following:**
- 6           **(1) A member who is a building level administrator.**
- 7           **(2) A member who is a school corporation superintendent.**
- 8           **(3) Two (2) additional members.**
- 9           **(d) The holder of a temporary superintendent's license is eligible**
- 10 **to serve as a superintendent in the prekindergarten through grade**
- 11 **12 school setting within the governing body's jurisdiction.**
- 12           **(e) A temporary superintendent's license is valid until the**
- 13 **termination or expiration of the holder's contract with the**
- 14 **governing body.**
- 15           **(f) An individual or governing body is not limited to one (1)**
- 16 **temporary superintendent's license."**
- 17           Renumber all SECTIONS consecutively.
