DIGEST OF SB 530 (Updated January 23, 2013 12:07 pm - DI 104)

**Citations Affected:** IC 12-14.

**Synopsis:** Schedule for electronic benefits transfers. Requires the division of family resources to, beginning January 1, 2014, implement a schedule for the distribution of Supplemental Nutrition Assistance Program (SNAP) benefits from the fifth through the twenty-third day of each month.

**Effective:** July 1, 2013.

Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. Also, the word **NEW** will appear in that style type in the introductory clause of each SECTION that adds a new provision to the Indiana Code or the Indiana Constitution.

## SENATE BILL No. 530

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 12-14-30 IS ADDED TO THE INDIANA CODE  
2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE  
3 JULY 1, 2013]:  
4 **Chapter 30. Supplemental Nutrition Assistance Program**  
5 **Sec. 1. As used in this chapter, "SNAP" refers to the federal**  
6 **Supplemental Nutrition Assistance Program under 7 U.S.C. 2011**  
7 **et seq.**  
8 **Sec. 2. (a) Beginning January 1, 2014, the division shall**  
9 **implement a schedule for the distribution of benefits to an**  
10 **approximately evenly distributed number of SNAP recipients**  
11 **during the fifth through the twenty-third day of each month.**  
12 **(b) The division may prorate benefits for a SNAP recipient for**  
13 **the first month the division begins to use the schedule described in**  
14 **subsection (a).**
