

COMMITTEE REPORT

MADAM PRESIDENT:

The Senate Committee on Education and Career Development, to which was referred Senate Bill No. 418, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1 Delete the title and insert the following:
- 2 A BILL FOR AN ACT to amend the Indiana Code concerning
- 3 education.
- 4 Page 1, between the enacting clause and line 1, begin a new
- 5 paragraph and insert:
- 6 "SECTION 1. IC 20-24-8-5, AS AMENDED BY P.L.160-2012,
- 7 SECTION 47, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 8 JULY 1, 2013]: Sec. 5. The following statutes and rules and guidelines
- 9 adopted under the following statutes apply to a charter school:

- 23 Page 2, delete line 26.
- 24 Page 2, line 32, delete "may" and insert **"shall"**.
- 25 Page 3, line 31, delete "public schools, including charter" and insert
- 26 **"a school corporation."**
- 27 Page 3, delete line 32.
- 28 Page 4, line 6, delete "only to public schools, including" and insert
- 29 **"to a school corporation."**
- 30 Page 4, delete line 7.
- 31 Page 4, delete lines 25 through 26.
- 32 Page 5, line 6, delete "the" and insert **"one (1) or more"**.
- 33 Page 5, line 7, delete "organization" and insert **"organizations"**.
- 34 Page 5, line 7, delete "with the" and insert **". The number of**
- 35 **members that a school employee organization may recommend for**
- 36 **appointment to the task force shall be proportional to the number**
- 37 **of members of that school employee organization as a percentage**
- 38 **of the members of all school employee organizations."**

- 1 Page 5, delete line 8.
- 2 Page 5, between lines 14 and 15, begin a new paragraph and insert:
- 3 **"(c) The state superintendent shall develop guidelines for**
- 4 **determining the number of members that a school employee**
- 5 **organization may recommend under subsection (a)(1)."**
- 6 Renumber all SECTIONS consecutively.
(Reference is to SB 418 as introduced.)

and when so amended that said bill do pass and be reassigned to the Senate Committee on Appropriations.
