

COMMITTEE REPORT

MADAM PRESIDENT:

The Senate Committee on Health and Provider Services, to which was referred Senate Bill No. 489, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1 Page 2, line 19, strike "or drawing".
- 2 Page 3, between lines 32 and 33, begin a new line block indented
- 3 and insert:
- 4 **"(4) At least eighteen (18) hours before the abortion and in the**
- 5 **presence of the pregnant woman, the physician who is to**
- 6 **perform the abortion, the referring physician or a physician**
- 7 **assistant (as defined in IC 25-27.5-2-10), an advanced practice**
- 8 **nurse (as defined in IC 25-23-1-1(b)), or a midwife (as defined**
- 9 **in IC 34-18-2-19) to whom the responsibility has been**
- 10 **delegated by the physician who is to perform the abortion or**
- 11 **the referring physician has provided the pregnant woman**
- 12 **with a color copy of the informed consent brochure described**
- 13 **in section 1.5 of this chapter by printing the informed consent**
- 14 **brochure from the state department's Internet web site and**
- 15 **including the following information on the back cover of the**
- 16 **brochure:**
- 17 **(A) The name of the physician performing the abortion**
- 18 **and the physician's medical license number.**
- 19 **(B) An emergency telephone number where the physician**
- 20 **or the physician's designee may be contacted twenty-four**
- 21 **(24) hours a day, seven (7) days a week.**

1 **(C) A statement that follow-up care by the physician or the**
 2 **physician's designee who is licensed under IC 25-22.5 is**
 3 **available on an appropriate and timely basis when**
 4 **clinically necessary."**

5 Page 3, after line 41, begin a new paragraph and insert:

6 "SECTION 2. IC 16-34-2-1.5, AS ADDED BY P.L.193-2011,
 7 SECTION 10, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 8 JULY 1, 2013]: Sec. 1.5. (a) The state department shall **develop an**
 9 **informed consent brochure and post Internet web site links**
 10 ~~concerning materials described in this section~~ **the informed consent**
 11 **brochure** on the state department's Internet web site.

12 (b) The state department shall ~~post Internet web site links relating~~
 13 ~~to materials~~ **develop an informed consent brochure** that ~~include~~
 14 **includes** the following:

15 (1) Objective scientific information concerning the probable
 16 anatomical and physiological characteristics of a fetus every two

17 (2) weeks of gestational age, including the following:

18 (A) Realistic pictures in color for each age of the fetus,
 19 including the dimensions of the fetus.

20 (B) Whether there is any possibility of the fetus surviving
 21 outside the womb.

22 (2) Objective scientific information concerning the medical risks
 23 associated with each abortion procedure, including the following:

24 (A) The risks of infection and hemorrhaging.

25 (B) The potential danger:

26 (i) to a subsequent pregnancy; or

27 (ii) of infertility.

28 (3) Information concerning the medical risks associated with
 29 carrying the child to term.

30 (4) Information that medical assistance benefits may be available
 31 for prenatal care, childbirth, and neonatal care.

32 (5) Information that the biological father is liable for assistance in
 33 support of the child, regardless of whether the biological father
 34 has offered to pay for an abortion.

35 (6) Information regarding telephone 211 dialing code services for
 36 accessing human services as described in IC 8-1-19.5, and the
 37 types of services that are available through this service.

38 (c) In complying with subsection (b)(6), the state department shall
 39 consult with the recognized 211 service providers and the Indiana
 40 utility regulatory commission as required by IC 8-1-19.5-9.

41 **(d) In the development of the informed consent brochure**
 42 **described in this section, the state department shall use**

- 1 **information and pictures that are available at no cost or nominal**
- 2 **cost to the state department.**
- 3 **(e) The informed consent brochure must include the**
- 4 **requirements specified in this chapter."**
- 5 Renumber all SECTIONS consecutively.
(Reference is to SB 489 as introduced.)

and when so amended that said bill do pass .
