

COMMITTEE REPORT

MADAM PRESIDENT:

The Senate Committee on Local Government, to which was referred House Bill No. 1145, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1 Page 1, delete lines 1 through 17.
- 2 Delete pages 2 through 10.
- 3 Page 11, delete lines 1 through 12.
- 4 Page 13, delete lines 38 through 42.
- 5 Page 14, delete lines 1 through 25.
- 6 Page 16, between lines 6 and 7, begin a new paragraph and insert:
- 7 "SECTION 14. IC 36-7-14-13, AS AMENDED BY P.L.112-2012,
- 8 SECTION 54, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 9 JULY 1, 2013]: Sec. 13. (a) ~~Within thirty (30) days after the close~~ **Not**
- 10 **later than March 15** of each ~~calendar~~ year, the redevelopment
- 11 commissioners shall file with the unit's executive a report setting out
- 12 their activities during the preceding calendar year.
- 13 (b) The report of the commissioners of a municipal redevelopment
- 14 commission must show the names of the then qualified and acting
- 15 commissioners, the names of the officers of that body, the number of
- 16 regular employees and their fixed salaries or compensation, the amount
- 17 of the expenditures made during the preceding year and their general
- 18 purpose, an accounting of the tax increment revenues expended by any
- 19 entity receiving the tax increment revenues as a grant or loan from the
- 20 commission, the amount of funds on hand at the close of the calendar

1 year, and other information necessary to disclose the activities of the
2 commissioners and the results obtained.

3 (c) The report of the commissioners of a county redevelopment
4 commission must show all the information required by subsection (b),
5 plus the names of any commissioners appointed to or removed from
6 office during the preceding calendar year.

7 (d) A copy of each report filed under this section must be submitted
8 to the department of local government finance in an electronic format
9 under IC 5-14-6.

10 SECTION 15. IC 36-7-15.1-36.3, AS ADDED BY P.L.112-2012,
11 SECTION 57, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
12 JULY 1, 2013]: Sec. 36.3. (a) ~~Within thirty (30) days after the close~~
13 **Not later than March 15** of each ~~calendar~~ year, the commission shall
14 file with the mayor a report setting out the commission's activities
15 during the preceding calendar year.

16 (b) The report required by subsection (a) must show the names of
17 the then qualified and acting commissioners, the names of the officers
18 of that body, the number of regular employees and their fixed salaries
19 or compensation, the amount of the expenditures made during the
20 preceding year and their general purpose, an accounting of the tax
21 increment revenues expended by any entity receiving the tax increment
22 revenues as a grant or loan from the commission, the amount of funds
23 on hand at the close of the calendar year, and other information
24 necessary to disclose the activities of the commission and the results
25 obtained.

26 (c) A copy of each report filed under this section must be submitted
27 to the department of local government finance in an electronic format
