

COMMITTEE REPORT

MADAM PRESIDENT:

The Senate Committee on Education and Career Development, to which was referred House Bill No. 1381, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1 Page 1, delete lines 1 through 15, begin a new paragraph and insert:
- 2 "SECTION 1. IC 20-18-2-18.5 IS ADDED TO THE INDIANA
- 3 CODE AS A **NEW SECTION TO READ AS FOLLOWS**
- 4 [EFFECTIVE JULY 1, 2013]: **Sec. 18.5. "Special curriculum" means**
- 5 **a course of study embracing subject matter or a teaching**
- 6 **methodology that is not generally offered to students of the same**
- 7 **age or grade level in the same school corporation. The term does**
- 8 **not include:**
- 9 **(1) a course of study or a part of a course of study designed**
- 10 **solely for special education or limited English proficient**
- 11 **students; or**
- 12 **(2) a course of study or part of a course of study in which any**
- 13 **student is unable to participate because of the student's**
- 14 **limited financial resources."**
- 15 Page 2, line 10, delete "in each:" and insert "; **and**".
- 16 Page 2, delete lines 11 through 12.
- 17 Page 2, line 13, delete "or within".
- 18 Page 2, line 27, delete "or within".
- 19 Page 2, line 37, delete "(i) and (j)," and insert "**(i), (j), and (k),**".
- 20 Page 2, line 39, delete "or within".
- 21 Page 3, delete lines 1 through 6, begin a new paragraph and insert:

1 **"(h) Except as provided in subsections (i), (j), and (k), the**
2 **governing body of a school corporation may not deny a request for**
3 **a student to transfer into the school corporation if the student**
4 **requesting to transfer:**

5 **(1) is a member of a household in which any other member of**
6 **the household is a student in the transferee school; or**
7 **(2) has a parent who is an employee of the school**
8 **corporation."**

9 Page 3, line 8, delete "within" and insert "**in**".

10 Page 3, line 18, delete "or within".

11 Page 3, between lines 33 and 34, begin a new paragraph and insert:

12 **"(k) The governing body of a school corporation with a school**
13 **building that offers a special curriculum may require a student**
14 **who transfers to the school building to meet the same eligibility**
15 **criteria required of all students who attend the school building that**
16 **offers the special curriculum."**

17 Page 3, line 34, delete "(k)" and insert "**(l)**".

18 Page 3, after line 38, begin a new paragraph and insert:

19 **"(m) A school corporation that has adopted a policy to not**
20 **accept student transfers after June 30, 2013, is not prohibited from**
21 **enrolling a transfer student who attended a school within the**
22 **school corporation during the 2012-2013 school year.**

23 **(n) A school corporation may not provide transportation for a**
24 **student who transfers under this section outside the attendance**
25 **area for the school corporation."**

26 ReNUMBER all SECTIONS consecutively.
