**EXECUTIVE ORDER: 06-17** 

FOR: THE EFFECTIVENESS OF POPULATION INFORMATION FROM THE UNITED STATES CENUS [sic.] BUREAU FOR STATE LAW PURPOSES

TO ALL TO WHOM THESE PRESENTS MAY COME, GREETINGS.

**WHEREAS**, Indiana Code 1-1-3.5-3 provides that, with respect to any Indiana statute that classifies political subdivisions based on their population according to the federal census results, the effective date of each federal special census, special tabulation, or corrected population count is April 1 of the calendar year following the year in which the tabulation of population or corrected population count is delivered to the State by the United States Secretary of Commerce under 13 U.S.C. 141 and is received by the Governor; and

**WHEREAS**, Indiana Code 1-1-3.5-3 further provides that the Governor shall issue an Executive Order upon receipt of the tabulation of population or corrected population count:

**NOW, THEREFORE, I, Mitchell E. Daniels, Jr.,** Governor of the State of Indiana, as required by Indiana Code 1-1-3.5-3, do hereby acknowledge delivery by the U.S. Secretary of Commerce of the following partial special census data as of the date set forth in the list below and note that the effective date of the partial special census for the political subdivision set forth opposite such date is April 1, 2007:

June 29, 2006 Town of Westfield Population: 9,722

Housing Count: 3,666

The above referenced numbers reflect only a portion of the population of the Town of Westfield, accounting for only 18 individual census blocks examined by the U.S. Census Bureau. The Town's total population will be a combination of these numbers in addition to the numbers from the remaining census blocks from Census 2000 that were not counted in the June 29, 2006 partial special census. In compliance with <a href="LC 1-1-3.5-5">LC 1-1-3.5-5</a>(a), I have forwarded a copy of this Executive Order to the Director of the Indiana State Library for distribution under <a href="LC 1-1-3.5-5">LC 1-1-3.5-5</a>(b), to the Election Division of the Office of the Secretary of State, and to the *Indiana Register* for publication.
