SECTION 1. <u>326 IAC 20-95</u> IS ADDED TO READ AS FOLLOWS:

Rule 95. Industrial, Commercial, and Institutional Boilers and Process Heaters

<u>326 IAC 20-95-1</u> Applicability; incorporation by reference of federal standards

Sec. 1. (a) This rule applies to sources as provided in 40 CFR 63.7485*.

(b) The air pollution control board incorporates by reference 40 CFR 63, Subpart DDDDD*, as amended by 70 FR 76933, December 28, 2005*, national emission standards for hazardous air pollutants for industrial, commercial, and institutional boilers and process heaters.

(c) Owners and operators may use the emission averaging provisions as specified under 40 CFR 63.7522*.

(d) Under <u>326 IAC 3-6</u>, source sampling procedures, a test protocol form for an emissions test is due thirty-five (35) days before the intended test date.
