

TITLE 25 INDIANA DEPARTMENT OF ADMINISTRATION**Readopted Final Rule**

DIGEST

Readopts rules in anticipation of [IC 4-22-2.5-2](#), providing that an administrative rule adopted under [IC 4-22-2](#) expires January 1 of the seventh year after the year in which the rule takes effect unless the rule contains an earlier expiration date. *NOTE: [IC 4-22-2.5-5](#) authorizes the Governor to postpone, by executive order, the expiration of rules for one year. Executive Order #07-22, issued December 28, 2007, and posted at [20080116-IR-GOV080004EOA](#), postponed the expiration of the rules in this document until January 1, 2009.* Effective 30 days after filing with the Publisher.
