**Notice of Changes in Methods and Standards for Medicaid**  
**Payment for Institutional Providers**

In accordance with public notice requirements of 42 CFR 447.205 and Section 1902(a)(13)(A) of the Social Security Act, the Indiana Family and Social Services Administration, Office of Medicaid Policy and Planning publishes this notice of proposed changes to the reimbursement methodology for Medicaid services provided by enrolled institutional providers, which includes inpatient hospitals, nursing facilities, nonstate owned intermediate care facilities for the mentally retarded (ICFs/MR), and community residential facilities for the developmentally disabled (CRFs/DD).

The Office of Medicaid Policy and Planning (OMPP) proposes to modify the institutional reimbursement formulas by reducing rates currently paid to institutional providers under the Medicaid state plan and state regulations at [405 IAC 1-10.5](#) (inpatient hospital), [405 IAC 1-12](#) (nonstate owned ICFs/MR and CRFs/DD), [405 IAC 1-14.5](#) (HIV nursing facility), [405 IAC 1-14.6](#) (nursing facility) by 5% effective July 1, 2009. Such reduction shall remain in effect through the end of that state fiscal year 2010, June 30, 2010. Beginning July 1, 2010, rates shall return to the level that was in effect prior to the 5% reduction.

This change in reimbursement is necessary in order to avoid a budgetary shortfall and to remain within the available Medicaid appropriation. It is estimated that the fiscal impact of these changes will be a savings in expenditures of \$31.9 million state and \$61.7 million federal for a total of approximately \$93.6 million in state fiscal year (SFY) 2010.
