DIGEST

Amends <u>170 IAC 1-1.5-1</u> to exempt an application for a certificate of territorial authority for communications service providers or notice of change form filed under <u>IC 8-1-32.5</u> from the ex parte rules of the commission. Effective 30 days after filing with the Publisher.

SECTION 1. 170 IAC 1-1.5-1 IS AMENDED TO READ AS FOLLOWS:

170 IAC 1-1.5-1 Definitions

Authority: IC 8-1-1-3 Affected: IC 8-1

Sec. 1. (a) The definitions in this section apply throughout this rule.

- (b) "Commission" refers to the Indiana utility regulatory commission.
- (c) "To file a report" means written testimony filed by or oral testimony presented by, or both, a technical employee in a pending proceeding.
- (d) "Proceeding" means a formally docketed proceeding before the commission. The term does not include any of the following:
 - (1) A rulemaking.
 - (2) A thirty (30) day filing under IC 8-1-2-42(a).
 - (3) A filing under IC 8-1-2-61.5(a).
 - (4) A petition under 170 IAC 7-4.
 - (5) An informal investigation.
 - (6) An investigation and disposition by the consumer affairs division of the commission.
 - (7) An application or notice of change form filed under IC 8-1-32.5.
 - (7) (8) An application or notice of change form filed under IC 8-1-34.
 - (e) "Technical employee" means an employee within one (1) of the commission's technical divisions.
