

Notice of Intent to Adopt a Rule

LSA Document #10-395

Under [IC 4-22-2-23](#), the Indiana Gaming Commission intends to adopt a rule concerning the following:

Amends [68 IAC 1-9-1](#) regarding the provision of a surveillance room for the commission. Amends [68 IAC 1-16-2](#) regarding the problem gambling toll free number listed on each admission ticket or boarding pass. Amends [68 IAC 2-1-5](#) regarding certificates of inspection. Amends [68 IAC 2-4-1](#) regarding definitions. Amends [68 IAC 5-1-1](#) regarding the definition of "applicant" and regarding commission approval for a transfer of ownership interest. Amends [68 IAC 5-1-2](#) regarding the required number of copies of the application and Personal Disclosure Form that an applicant must submit. Amends [68 IAC 5-1-4](#) regarding requirements for institutional investors that acquire ownership. Amends [68 IAC 5-2-1](#) regarding definitions and ownership interests. Amends [68 IAC 5-2-2](#) regarding the required number of copies of a transfer application and the Personal Disclosure Form that an applicant must submit. Adds [68 IAC 5-2-3.2](#) regarding the requirement that institutional investors notify the commission after acquiring an ownership interest. Amends [68 IAC 5-3-1](#) regarding materiality of debt transactions. Adds [68 IAC 5-3-1.5](#) regarding financial stability. Amends [68 IAC 5-3-2](#) regarding approval of a material debt transaction. Amends [68 IAC 5-3-4](#) regarding the executive director's authority to deny a debt transaction. Amends [68 IAC 6-2-1](#) regarding eviction criteria. Adds [68 IAC 9-3-3.5](#) regarding deviation from provisions. Amends [68 IAC 15-6-1](#) regarding definitions. Makes numerous technical changes.
