Amends <u>511 IAC 5-3-2</u> to incorporate phaseout of Core 40 waiver. Repeals <u>511 IAC 5-3-1</u> and <u>511 IAC 5-3-4</u>. Effective 30 days after filing with the Publisher.

511 IAC 5-3-1, 511 IAC 5-3-2, 511 IAC 5-3-4

SECTION 1. 511 IAC 5-3-2 IS AMENDED TO READ AS FOLLOWS:

511 IAC 5-3-2 Completion of Core 40

Authority: <u>IC 20-19-2-8</u>; <u>IC 20-32-5-22</u> Affected: <u>IC 20-30-10-1</u>; <u>IC 20-32-4</u>

Sec. 2. **Before July 1, 2010,** a student who does not receive a passing score on the graduation examination may be eligible to graduate if the principal of the school the student attends certifies that the student will, within one (1) month of the student's scheduled graduation date, complete all components of the Core 40 curriculum established under <u>IC 20-30-10-1</u> with a grade of "C" or higher in all required and directed elective courses.
