## **DIGEST**

Amends <u>575 IAC 1-2-49</u> to allow stainless steel exterior mirror backs and bracket supports on Indiana's school buses. Makes technical corrections. Effective 30 days after filing with the Publisher.

SECTION 1. <u>575 IAC 1-2-49</u> IS AMENDED TO READ AS FOLLOWS:

575 IAC 1-2-49 Mirrors

Authority: <u>IC 20-27-3-4</u> Affected: <u>IC 20-27-9</u>

Sec. 49. (a) The interior clear-view mirror must:

- (1) be made of safety glass;
- (2) be at least six (6) inches by sixteen (16) inches overall; and
- (3) afford a good view of pupils; It must and
- (4) have rounded corners and protected edges.
- (b) There must be one (1) exterior clear-view, rearview mirror on the left side of the driver and one (1) clear-view, rearview mirror on the right side of the driver. Each mirror must be at least **fifty** (50) square inches and firmly supported and adjustable to give the driver a clear view of the left and right rear of the bus.
- (c) When an indirect visibility system is used to meet the requirements of this section, the system must consist of two (2) crossover and two (2) rear-facing mirrors that are eight (8) inches convex and have a seven and one-half (7 1/2) inch reflective area. This system must be mounted at the frontmost portion of the bus fender to provide visibility to the area in front of the bus and the area immediately adjacent to the left and right front wheels. Elliptical or hemispherical mirrors may be substituted on a two-for-one basis if indirect visibility requirements are met.
  - (d) Exterior mirror backs and bracket supports must be black or stainless steel.

SECTION 2. 575 IAC 1-7-1 IS AMENDED TO READ AS FOLLOWS:

575 IAC 1-7-1 General provision

Sec. 1. Any deviation from the preceding standards must be approved by the department of education **unless otherwise stated in this rule.** If the department denies a request to place additional equipment on the bus, an appeal may be made to the state school bus committee.
