**TITLE 877 REAL ESTATE APPRAISER LICENSURE AND CERTIFICATION BOARD**

**DIGEST**

Adds 877 IAC to comply with [IC 25-34.1-11.2](#) to provide that the Real Estate Appraiser Licensure and Certification Board establishes a registration fee of \$500 for appraisal management companies seeking registration under [IC 25-34.1-11.2](#) that will be deposited in the Indiana Real Estate Investigative Fund established by [IC 25-34.1-8-7.5](#). Effective 30 days after filing with the Publisher.

**Sec. 1. (a) This section establishes the fee schedule for the registration of appraisal management companies.**

**(b) The fee schedule is as follows:**

**(1) Registration for appraisal management companies: \$500**

**(2) Renewal of registration for appraisal management companies: \$500**

**(c) Registration fees and renewal of registration fees shall be deposited in the investigative fund established under [IC 25-34.1-8-7.5](#).**

**(d) All fees are nonrefundable and nontransferable.**
