Under [IC 4-22-2-24](#), notice is hereby given that on **September 27, 2013**, at 9:00 a.m., at the Indiana Government Center South, 402 West Washington Street, Conference Center Room 3, Indianapolis, Indiana, the Office of the Secretary of Family and Social Services will hold a public hearing on a proposed rule adding [405 IAC 5-16.5](#) for purposes of including freestanding birthing center services as services covered by Medicaid, including definitions, eligibility requirements, a description of covered services, and reimbursement for services.

The proposed rule will not impose any additional requirements or costs under [IC 4-22-2-24\(d\)\(3\)](#). The proposed rule creates no unfunded mandates on state agencies or political subdivisions.

All persons interested in the proposed rule are invited to attend the public hearing and to offer comments at the public hearing. In addition, written comments may be sent to the FSSA Office of General Counsel, Attention: Barbara Nardi, Indiana Government Center South, 402 W. Washington St., Room W451, Indianapolis, IN 46204 and must be received on or before September 27, 2013, at 5:00 p.m., in order to be considered.
