## **Emergency Rule**

## **DIGEST**

Temporarily amends <u>856 IAC 2-2-2</u> to add synthetic drug compounds to Schedule I. Statutory authority: <u>IC 25-26-13-4.1</u>. Effective 30 days after filing with the Publisher.

## SECTION 1. (a) This SECTION is supplemental to 856 IAC 2-2-2.

- (b) Unless specifically excepted or unless listed in another schedule, any material, compound, mixture, or preparation, which contains any quantity of the following synthetic substances, or which contains any of its salts, isomers, and salts of isomers, whenever the existence of such salts, isomers, and salts of isomers is possible within the specific chemical designation (for purposes of this subsection only, "isomer" includes the optical, position, and geometric isomers):
  - (1) AKB48 (Other names include: N-Adamantyl-1-pentyl-1H-Indazole-3-carboxamide; or
  - 1-pentyl-N-tricyclo[3.3.1.13.7]dec-1-yl-1H-indazole-3-carboxamide).
  - (2) CB-13 (Other names include: Naphthalen-1-yl-(4-pentyloxynaphthalen-1-yl)methanone; or SAB-378).
  - (3) 25I-NBOMe (Other names include:
  - 4-lodo-2,5-dimethoxy-N-[(2-methoxyphenyl)methyl]-benzeneethanamine); or
  - 2-(4-iodo-2,5-dimethoxyphenyl)-N-[(2-methoxyphenyl)methyl]ethanamine.
  - (4) 2C-C-NBOMe (Other names include: 25C-NBOMe;
  - 2-(4-chloro-2,5-dimethoxyphenyl)-N-[(2-methoxyphenyl)methyl]ethanamine; or
  - 2,5-Dimethoxy-4-chloro-N-(2-methoxybenzyl)phenethylamine).
  - (5) 2NE-1 (Other names include: 1-Pentyl-3-(1-adamantylamido)indole).
  - (6) STS-135 (Other names include: N-Adamantyl-1-fluoropentylindole-3-carboxamide or
  - (1-5-fluoropentyl)-N-tricyclo[3.3.1.13.7]dec-1-yl-1H-indole-3-carboxamide).
  - (7) URB597 (Other names include: [3-(3-carbamoylphenyl)phenyl] N-cyclohexylcarbamate or (3'-(aminocarbonyl)[1,1'-biphenyl]-3-yl)-cyclohexylcarbamate).
