This rulemaking will also update requirements to meet current federal standards and maintain the existing permit by rule general permits for those categories for which the U.S. EPA has not yet approved the administratively issued general permits.

All interested persons are invited and will be given reasonable opportunity to express their views concerning the proposed new rules and amendments.
