DIGEST

Adds <u>410 IAC 15-1.1-18.5</u> to include the definition of "qualified dietitian". Amends <u>410 IAC 15-1.5-1</u> to comply with the conditions of participation in food and dietetic services as required by HEA 1157-2015 and 42 CFR 482.28. Amends <u>410 IAC 17-9-20</u> by updating the definition of "medication assistance" to comply with SEA 358-2015. Effective 30 days after filing with the Publisher.

SECTION 1. 410 IAC 15-1.1-18.5 IS ADDED TO READ AS FOLLOWS:

410 IAC 15-1.1-18.5 "Qualified dietitian" defined

Sec. 18.5. "Qualified dietitian" means an individual as defined in IC 25-14.5-1-15.

SECTION 2. 410 IAC 15-1.5-1 IS AMENDED TO READ AS FOLLOWS:

410 IAC 15-1.5-1 Dietetic services

Authority: <u>IC 16-21-1-7</u> Affected: <u>IC 16-21-1</u>

Sec. 1. (a) The hospital shall have organized food and dietary services that are directed and staffed by adequate, qualified personnel, or a contract with an outside food management company that meets the minimum standards specified in this section.

- (b) The food and dietetic service shall have the following:
- (1) A full-time employee who:
 - (A) serves as director of the food and dietetic services; and
 - (B) is responsible for the daily management of the dietary services.
- (2) A qualified dietitian, full-time, part-time, or on a consulting basis. If a consultant is used, he or she shall:
 - (A) submit periodic written reports on the dietary services provided; and
 - (B) provide the number of on-site dietitian hours commensurate with:
 - (i) the type of dietary supervision required:
 - (ii) the bed capacity; and
 - (iii) the complexity of the patient care services.
- (3) Administrative and technical personnel competent in their respective duties.
- (c) The dietary service shall do the following:
- (1) Provide for liaison with the hospital medical staff for recommendations on dietetic policies affecting patient treatment.
- (2) Correlate and integrate dietary care functions with those of other patient care personnel which include, but are not limited to, the following:
 - (A) Patient nutritional assessment and intervention.
 - (B) Recording pertinent information on the patient's chart.
 - (C) Conferring with and sharing specialized knowledge with other members of the patient care team.
- (d) Menus shall meet the needs of the patients as follows:
- (1) Therapeutic diets shall be prescribed by the practitioner responsible for the care of the patient, or by a

qualified dietitian as authorized by the medical staff.

- (2) Nutritional needs shall be met in accordance with recognized dietary standards of practice and in accordance with the orders of the responsible practitioner **or qualified dietitian**.
- (3) A current therapeutic diet manual approved by the dietitian and medical staff shall be readily available to all medical, nursing, and food service personnel.

SECTION 3. 410 IAC 17-9-20 IS AMENDED TO READ AS FOLLOWS:

410 IAC 17-9-20 "Medication assistance" defined

Authority: <u>IC 16-27-1-7</u> Affected: <u>IC 16-27-1</u>

Sec. 20. "Medication assistance" means the provision of assistance:

- (1) through providing reminders or cues to take medication, the opening of pre-set medication containers, and providing assistance in the handling or ingesting of noncontrolled substance medications, including controlled substances, prescription drugs, eye drops, herbs, supplements, and over-the-counter medications; and
- (2) to an individual who is unable to accomplish the task due to an impairment and who is:
 - (A) competent and has directed the services; or
 - (B) incompetent and has the services directed by a competent individual who may consent to health care for the impaired individual.
