#### DIGEST

Amends <u>312 IAC 8-2-5</u> to allow the possession or consumption of an alcoholic beverage at Indiana Dunes State Park as authorized by <u>IC 7.1-3-17.8</u>. Effective 30 days after filing with the Publisher.

# 312 IAC 8-2-5

SECTION 1. 312 IAC 8-2-5 IS AMENDED TO READ AS FOLLOWS:

# 312 IAC 8-2-5 Alcoholic beverages

Authority: <u>IC 14-10-2-4</u>; <u>IC 14-11-2-1</u> Affected: <u>IC 7.1-3-17.8</u>; <u>IC 14-18-2-3</u>

Sec. 5. A person must not possess or consume an alcoholic beverage at any of the following locations:

- (1) **Subject to subdivisions (4) and (6)**, Indiana Dunes State Park, except <del>on the licensed premises of a pavilion authorized by a location:</del>
  - (A) identified in a permit issued pursuant to <a href="IC 7.1-3-17.8">IC 7.1-3-17.8</a>; or
  - (B) designated in a lease and contract authorized under <u>IC 14-18-2-3</u>.
- (2) Redbird State Recreation Area.
- (3) Interlake State Recreation Area.
- (4) A swimming beach or pool.
- (5) A shooting range.
- (6) A designated youth tent area.
