DIGEST

Temporarily amends <u>326 IAC 1-4</u> to designate Clark and Floyd counties to nonattainment for the 2015 ozone standard. Statutory authority: <u>IC 13-14-8-1</u>. Effective August 9, 2018.

SECTION 1. (a) This SECTION supersedes 326 IAC 1-4-11.

(b) The following attainment status designations are applicable to Clark County:
