DIGEST

Temporarily supplements [312 IAC 14-3-3](#) by adding a list of disqualifying crimes and related provisions, implementing [IC 25-1-1.1-6](#). Statutory authority: [IC 25-1-1.1-6](#). Effective November 1, 2018.

SECTION 1. This document implements [IC 25-1-1.1-6](#) regarding disqualifying criminal history for licensing as a timber buyer or timber buyer agent by the Indiana department of natural resources and includes in SECTION 3 of this document an explicit list of crimes that will disqualify an individual from receiving a license.

SECTION 2. An applicant for licensure who has a disqualifying criminal history may still be granted a license based on the criteria stated in [IC 25-1-1.1-6\(f\)](#).

SECTION 3. This SECTION contains the list of disqualifying crimes as follows and is supplemental to [312 IAC 14-3-3](#):

- (1) Arson ([IC 35-43-1-1\(a\)\(1\)](#)).

SECTION 4. A crime in any other jurisdiction for which the elements of the crime for which conviction was entered are substantially similar to the elements of a crime included on the list in SECTION 3 of this document shall also be a crime that will disqualify an individual from receiving a license and therefore included on the list.

SECTION 5. SECTIONS 1 through 4 of this document take effect November 1, 2018.
