Emergency Rule LSA Document #18-511(E)

DIGEST

Temporarily amends <u>326 IAC 1-4</u> to designate Clark and Floyd counties to nonattainment for the 2015 ozone standard. Statutory authority: <u>IC 13-14-8-1</u>. *NOTE: The original emergency document, LSA Document #18-330(E), posted at <u>20180815-IR-326180330ERA</u>, effective August 9, 2018, expired November 7, 2018. Effective November 15, 2018.*

SECTION 1. (a) This SECTION supersedes 326 IAC 1-4-11.
