DIGEST

Temporarily amends [326 IAC 1-4](#) to designate Clark and Floyd counties to nonattainment for the 2015 ozone standard. Statutory authority: [IC 13-14-8-1](#). *NOTE: The original emergency document, LSA Document #18-330(E), posted at [20180815-IR-326180330ERA](#), effective August 9, 2018, expired November 7, 2018. Effective November 15, 2018.*

SECTION 1. (a) This SECTION supersedes [326 IAC 1-4-11](#).

(b) The following attainment status designations are applicable to Clark County:

Pb	Unclassifiable or attainment effective December 31, 2011, for the 2008 lead standard.
