Letter of Findings: 01-20181697 Individual Income Tax For the Tax Year 2015

HOLDING

Individual failed to provide documentation supporting his position that the Department's proposed assessment of additional Indiana individual income tax was incorrect for the year at issue.

ISSUE

I. Income Tax-Burden of Proving Assessment Incorrect.

Tax Ct. 2007); Indiana Dep't of State Revenue v. Rent-A-Center East, Inc., 963 N.E.2d 463 (Ind. 2012); Scopelite v. Indiana Dep't of Local Gov't Fin., 939 N.E.2d 1138 (Ind. Tax Ct. 2010); Wendt LLP v. Indiana Dep't of State Revenue, 977 N.E.2d 480 (Ind. Tax Ct. 2012).

Taxpayer protests the imposition of Indiana individual income tax for tax year 2015.

STATEMENT OF FACTS

Taxpayer filed his 2015 Indiana tax return on March 15, 2016. In June of 2018, based on information from the Internal Revenue Service (IRS), the Indiana Department of Revenue ("Department") adjusted Taxpayer's 2015 return which resulted in an assessment. The Department issued Taxpayer a proposed assessment for the amount of the assessment, plus penalty and interest. Taxpayer protested the assessment and waived his right to a hearing. Thus, this Letter of Findings is based on the information available to the Department and provided in Taxpayer's protest file. Additional facts will be provided as necessary.

I. Income Tax-Burden of Proving Assessment Incorrect.

DISCUSSION

Due to a federal adjustment to Taxpayer's 2015 income tax return, the Department adjusted Taxpayer's Indiana 2015 tax return, resulting in a decrease in the refund due to the Taxpayer. The Department assessed Taxpayer for the amount of the decrease plus penalty and interest. Taxpayer protested the assessment but waived his right to a hearing.

As a threshold issue, all tax assessments are *prima facie* evidence that the Department's claim for unpaid tax is valid; the taxpayer bears the burden of proving that any assessment is incorrect. IC § 6-8.1-5-1(c); *Indiana Dep't. of State Revenue v. Rent-A-Center East, Inc.*, 963 N.E.2d 463, 466 (Ind. 2011); *Lafayette Square Amoco, Inc. v. Indiana Dept. of State Revenue*, 867 N.E.2d 289, 292 (Ind. Tax Ct. 2007). Consequently, the taxpayer is required to provide documentation explaining and supporting its challenge that the Department's position is wrong. Poorly developed and non-cogent arguments are subject to waiver. *Scopelite v. Indiana Dep't of Local Gov't Fin.*, 939 N.E.2d 1138, 1145 (Ind. Tax Ct. 2010); *Wendt LLP v. Indiana Dep't of State Revenue*, 977 N.E.2d 480, 486 n.9 (Ind. Tax Ct. 2011).

Indiana imposes an adjusted gross income tax on all residents. IC § 6-3-2-1(a). A taxpayer's Indiana income is determined by starting with the federal adjusted gross income and making certain adjustments. IC § 6-3-1-3.5(a). IC § 6-3-2-2(a) specifically outlines what is income derived from Indiana sources and subject to Indiana income tax. For Indiana income tax purposes, the presumption is that taxpayers properly and correctly file their federal income tax returns as required pursuant to the Internal Revenue Code. Thus, to efficiently and effectively

compute what is considered the taxpayer's Indiana income tax, the Indiana statute refers to the Internal Revenue Code. IC § 6-3-1-3.5(a) provides the starting point to determine the taxpayer's taxable income and to calculate what would be their Indiana income tax after applying certain additions and subtractions to that starting point.

In June of 2018, the Department adjusted Taxpayer's 2015 Indiana income tax return based on information it received from the IRS. The Department then issued Taxpayer a proposed assessment as a result of the adjustment. Taxpayer protested the assessment; Taxpayer only provided the proposed assessments and a returned check for the amount of \$69.12. Taxpayer also submitted a "Protest Submission Form" in which he opted to forgo an administrative hearing.

The Department reviewed Taxpayer's protest and in a letter to Taxpayer dated July 26, 2018, informed Taxpayer that the assessment "is the result of a discrepancy between the amount of Exemptions and/or the amount of Dependents reported on your federal return in comparison to the amount reported on your Indiana state return." The letter went on to state that if Taxpayer disagrees with the adjustment, he should provide a copy of his Federal Record of Account to the Department by August 27, 2018. The Department's letter also provided two means through which Taxpayer could obtain his Federal Record of Account. Taxpayer has failed to provide this documentation.

As stated above, it is the Taxpayer's burden to prove that the Department's assessment is incorrect. In doing so, a taxpayer is required to provide documentation to support his position. Without Taxpayer's Federal Record of Account, the Department cannot begin to determine whether Taxpayer's original return was correct, as argued by Taxpayer. Furthermore, Taxpayer appeared to think he paid the assessment based on the return check for the amount of \$69.12. That check however was a payment for 2013 taxes due, not this 2015 assessment. Thus, Taxpayer has failed to meet his burden under IC § 6-8.1-5-1(c). Taxpayer's protest is denied.

FINDING

Taxpayer's protest is denied.
