OCCUPATIONAL SAFETY STANDARDS COMMISSION Adoption by Reference Bulletin #19-03

<u>IC 22-8-1.1-16.2</u> provides that a United States Occupational Safety and Health Administration (OSHA) standard lawfully adopted by OSHA under federal law may be enforced by the Indiana Department of Labor not earlier than sixty (60) days after the final standard by federal OSHA becomes effective. The Indiana Department of Labor shall publish a statement describing a standard enforceable under this section and making reference to the federal regulation. The statement must be published under <u>IC 4-22-7-7(b)</u>.

The Indiana Department of Labor incorporates by reference the U.S. Department of Labor, Occupational Safety and Health Administration Final Rule for the Standards Improvement Project-Phase IV (SIP-IV), which is intended to remove or revise outdated, duplicative, unnecessary, and inconsistent requirements in OSHA's safety and health standards. This rule amends the following topics in the parts listed: 29 CFR Part 1904, Recordkeeping; 29 CFR Part 1910, Chest X-ray requirements, Incorporation by reference, Pulmonary–function testing, and Social Security numbers on records; 29 CFR Part 1915, Chest X-ray requirements, Incorporation by reference, Sanitation, and Social Security numbers on records; 29 CFR Part 1926, Airborne contaminants, Chest X-ray requirements, Coke oven emissions, Diesel equipment, Emergency services, Incorporation by reference, Lanyards, Load limits, Manual on Uniform Traffic Control Devices (MUCTD), Personal protective equipment (PPE), Process safety management (PSM), Roll-over protective structures (ROPs), and Social Security numbers on records.
