# Emergency Rule

## DIGEST

Temporarily amends 326 IAC 1-4 to designate Clark and Floyd counties to nonattainment for the 2015 ozone standard. Statutory authority: IC 13-14-8-1. NOTE: The original emergency document, LSA Document #19-289(E), posted at 20190522-IR-326190289ERA, effective May 15, 2019, expired August 13, 2019. Effective August 20, 2019.
