Temporarily adds noncode provisions and amends <u>655 IAC 1-2.1</u> to regulate the certification requirements concerning the Training for Voluntary Certification Program to include the most current edition and standards of the following National Fire Protection Association (NFPA) standards: 472, 1001, 1002, 1003, 1006, 1021, 1031, 1033, 1035, 1041, and 1521. Statutory authority: <u>IC 36-8-10.5-7</u>. Effective January 1, 2020.

 - (8) use and limitations of teaching methods and techniques;
 - (9) how to supervise other instructors and students during training, given a training scenario with increased hazard exposure, so that applicable safety standards and practices are followed and instructional goals are met;
