Emergency Rule LSA Document #20-67(E)

DIGEST

Temporarily amends 326 IAC 1-4-46 and 326 IAC 1-4-65 to reclassify Lake and Porter counties from moderate nonattainment to serious nonattainment for the 2008 8-hour ozone National Ambient Air Quality Standards (NAAQS), and amends 326 IAC 1-4-85 to redesignate Fayette and Harrison townships in Vigo County to attainment for the 2010 primary 1-hour sulfur dioxide (SO₂) NAAQS. *NOTE: The original emergency document, LSA Document #19-593(E) posted at 20191120-IR-326190593ERA*, effective November 14, 2019, expires February 12, 2020. Statutory authority: IC 13-14-8-1. Effective February 12, 2020.

SECTION 1. (a) This SECTION supersedes 326 IAC 1-4-46.

(b) The following attainment status designations are applicable to Lake County:

SO ₂	Better than national standards.
СО	Attainment effective February 18, 2000, for the part of the city of East Chicago bounded by Columbus Drive on the north; the Indiana Harbor Canal on the west; 148th Street, if extended, on the south; and Euclid Avenue on the east. Unclassifiable or attainment effective November 15, 1990, for the remainder of East Chicago and Lake County.
03	Serious nonattainment effective September 23, 2019, for the 2008 8-hour ozone standard.

Pb	Unclassifiable or attainment effective December 31, 2011, for the 2008 lead standard.

SECTION 2. (a) This SECTION supersedes 326 IAC 1-4-65.
