Amends [345 IAC 4-4-1](#) to update the incorporation by reference of the federal National Poultry Improvement Plan (NPIP) regulations from January 1, 2015, to January 1, 2019. Effective 30 days after filing with the Publisher.

- (3) 9 CFR Part 147. But, 9 CFR Part 147, Subpart E is not incorporated by reference.
