Under [IC 4-22-2-24](#), [IC 13-14-8-6](#), and [IC 13-14-9.5-1.1](#), notice is hereby given that on **September 9, 2020, at 1:30 p.m.**, the Environmental Rules Board (ERB) will hold a public hearing **through Zoom** on listed rules that have been effective seven years that are: (1) rules required to receive or maintain delegation, primacy, or approval for implementation or operation of a program established under federal law; or (2) rules required to begin or continue receiving federal funding for implementation or operation of a program.

The purpose of this hearing is to receive comments from the public on specific rules that should be reviewed through the regular rulemaking process under [IC 13-14-9](#). All interested persons are invited and will be given reasonable opportunity to express their views concerning whether a listed rule should be reviewed through the regular rulemaking process.
