

TITLE 326 AIR POLLUTION CONTROL DIVISION

Emergency Rule
LSA Document #20-423(E)

DIGEST

Temporarily amends [326 IAC 1-4-46](#) and [326 IAC 1-4-65](#) to reclassify Lake and Porter counties from moderate nonattainment to serious nonattainment for the 2008 8-hour ozone National Ambient Air Quality Standards (NAAQS), and amends [326 IAC 1-4-85](#) to redesignate Fayette and Harrison townships in Vigo County to attainment for the 2010 primary 1-hour sulfur dioxide (SO₂) NAAQS. Statutory authority: [IC 13-14-8-1](#). Effective August 6, 2020.

SECTION 1. (a) This SECTION supersedes [326 IAC 1-4-46](#).

(b) The following attainment status designations are applicable to Lake County:

Pollutant	Designation
SO ₂	Better than national standards.
CO	Attainment effective February 18, 2000, for the part of the city of East Chicago bounded by Columbus Drive on the north; the Indiana Harbor Canal on the west; 148th Street, if extended, on the south; and Euclid Avenue on the east. Unclassifiable or attainment effective November 15, 1990, for the remainder of East Chicago and Lake County.
O ₃	Serious nonattainment effective September 23, 2019, for the 2008 8-hour ozone standard.
O ₃	Marginal nonattainment effective August 3, 2018, for the 2015 8-hour ozone standard for Calumet Township, Hobart Township, North Township, Ross Township, and St. John Township. Unclassifiable or attainment effective August 3, 2018, for the 2015 8-hour ozone standard for the remainder of the county.
PM _{2.5}	Unclassifiable effective April 15, 2015, for the 2012 annual PM _{2.5} standard.
PM _{2.5}	Unclassifiable or attainment effective December 13, 2009, for the 2006 24-hour PM _{2.5} standard.
PM ₁₀	Attainment effective March 11, 2003, for the cities of East Chicago, Hammond, Whiting, and Gary. Unclassifiable effective November 15, 1990, for the remainder of Lake County.
NO ₂	Unclassifiable or attainment effective January 29, 2012, for the 2010 NO ₂ standard.
Pb	Unclassifiable or attainment effective December 31, 2011, for the 2008 lead standard.

SECTION 2. (a) This SECTION supersedes [326 IAC 1-4-65](#).

(b) The following attainment status designations are applicable to Porter County:

Pollutant	Designation
SO ₂	Cannot be classified for the area bounded on the north by Lake Michigan; on the west by the Lake County and Porter County line; on the south by I-80 and I-90; and on the east by the LaPorte County and Porter County line. The remainder of Porter County is better than national standards.
CO	Unclassifiable or attainment effective November 15, 1990.
O ₃	Serious nonattainment effective September 23, 2019, for the 2008 8-hour ozone standard.
O ₃	Unclassifiable or attainment effective August 3, 2018, for the 2015 8-hour ozone standard.
PM _{2.5}	Unclassifiable effective April 15, 2015, for the 2012 annual PM _{2.5} standard.
PM _{2.5}	Unclassifiable or attainment effective December 13, 2009, for the 2006 24-hour PM _{2.5} standard.

PM₁₀	Unclassifiable effective November 15, 1990.
NO₂	Unclassifiable or attainment effective January 29, 2012, for the 2010 NO ₂ standard.
Pb	Unclassifiable or attainment effective December 31, 2011, for the 2008 lead standard.

SECTION 3. (a) This SECTION supersedes [326 IAC 1-4-85](#).

(b) The following attainment status designations are applicable to Vigo County:

Pollutant	Designation
SO₂	Attainment effective July 8, 2019, for the 2010 SO ₂ standard for Fayette and Harrison townships. Unclassifiable or attainment effective April 9, 2018, for the remainder of the county.
CO	Unclassifiable or attainment effective November 15, 1990.
O₃	Unclassifiable or attainment effective January 16, 2018, for the 2015 8-hour ozone standard.
PM_{2.5}	Unclassifiable or attainment effective April 15, 2015, for the 2012 annual PM _{2.5} standard.
PM_{2.5}	Unclassifiable or attainment effective December 13, 2009, for the 2006 24-hour PM _{2.5} standard.
PM₁₀	Unclassifiable effective November 15, 1990.
NO₂	Unclassifiable or attainment effective January 29, 2012, for the 2010 NO ₂ standard.
Pb	Unclassifiable or attainment effective December 31, 2011, for the 2008 lead standard.
