**TITLE 905 ALCOHOL AND TOBACCO COMMISSION**

**Notice of Intent to Readopt**

LSA Document #20-447

Readopts rules in anticipation of [IC 4-22-2.5-2](#), providing that an administrative rule adopted under [IC 4-22-2](#) expires January 1 of the seventh year after the year in which the rule takes effect unless the rule contains an earlier expiration date. *NOTE: [IC 4-22-2.5-5](#) authorizes the Governor to postpone, by executive order, the expiration of rules for one year. Executive Order #19-03, issued December 23, 2019, and posted at [20200101-IR-GOV190689EOA](#), postpones the expiration of [905 IAC 1-15.3-1](#) and [905 IAC 1-33.1-1](#) in this document until January 1, 2021. Effective 30 days after filing with the Publisher.*
