DIGEST

Temporarily amends <u>326 IAC 1-4-46</u> and <u>326 IAC 1-4-65</u> to reclassify Lake and Porter counties from moderate nonattainment to serious nonattainment for the 2008 8-hour ozone National Ambient Air Quality Standards (NAAQS), and amends <u>326 IAC 1-4-85</u> to redesignate Fayette and Harrison townships in Vigo County to attainment for the 2010 primary 1-hour sulfur dioxide (SO₂) NAAQS. Statutory authority: <u>IC 13-14-8-1</u>. *NOTE: The original emergency document, LSA Document #20-423(E) posted at <u>20200812-IR-326200423ERA</u>, effective August 6, 2020, expires November 4, 2020. Effective November 5, 2020.*

SECTION 1. (a) This SECTION supersedes <u>326 IAC 1-4-46</u>.

(b) The following attainment status designations are applicable to Lake County:

Pb	Unclassifiable or attainment effective December 31, 2011, for the 2008 lead standard.
