Under [IC 4-22-2-24](#), [IC 13-14-8-6](#), and [IC 13-14-9](#), notice is hereby given that on February 10, 2021, at 1:30 p.m., the Environmental Rules Board (ERB) will hold a public hearing through Zoom on amendments to [326 IAC 8-3-1](#), [326 IAC 8-3-2](#), [326 IAC 8-3-3](#), [326 IAC 8-3-4](#), and [326 IAC 8-3-8](#), concerning cold cleaning degreasing and the addition of a control device option to comply with the requirement to use a low vapor pressure solvent. The proposed rule is being republished to include several comments that were unintentionally omitted during the second notice of comment period.

The purpose of this hearing is to receive comments from the public prior to consideration of final adoption of these rules by the board. All interested persons are invited and will be given reasonable opportunity to express their views concerning the proposed amendments.
