# TITLE 326 AIR POLLUTION CONTROL DIVISION

## **Emergency Rule**

LSA Document #22-284(E)

#### DIGEST

Temporarily amends <u>326 IAC 1-4-46</u> and <u>326 IAC 1-4-65</u> to update the attainment designation status for Lake and Porter counties for the 2008 8-hour ozone standard, and the 2015 8-hour ozone standard for specific townships in Porter County. Statutory authority: <u>IC 13-14-8-1</u>. Effective September 15, 2022.

#### SECTION 1. (a) This SECTION supersedes 326 IAC 1-4-46.
