**TITLE 905 ALCOHOL AND TOBACCO COMMISSION**

**Notice of Public Comment Period for Rule Readoption**

LSA Document #23-624

Readopts rules in anticipation of [IC 4-22-2.6](#), providing that an administrative rule adopted under [IC 4-22-2](#) expires January 1 of the fifth year after the year in which the rule takes effect unless the rule contains an earlier expiration date. Effective 30 days after filing with the Publisher.

**SUMMARY OF FINDINGS UNDER [IC 4-22-2.6-4](#)**

The Indiana Alcohol and Tobacco Commission (commission) hereby finds that this rule readoption:

- (1) does not impose any expenses on regulated entities, persons who pay taxes or pay fees for government services, or consumers of products and services of regulated entities;
- (2) achieves its regulatory goal in the least restrictive manner;
- (3) avoids duplicating standards found in state or federal laws;
- (4) is written for ease of comprehension; and
- (5) has practicable enforcement.

The commission also hereby finds that there are no alternative methods of achieving the purpose of the rule that are less costly or less intrusive. Since its last readoption, the agency has not received any complaints or comments from the public concerning the rule or its implementation, has not encountered any difficulties in administering the rule, and there are no technological or economic conditions that have changed in the area affected by the rule since the last time the rule was reviewed and readopted.
