DIGEST

Readopts rules in anticipation of [IC 4-22-2.6](#), providing that an administrative rule adopted under [IC 4-22-2](#) expires January 1 of the fifth year after the year in which the rule takes effect unless the rule contains an earlier expiration date [*The Notice of Intent to Readopt for this rule was filed before July 1, 2023, under [IC 4-22-2.5](#) (before its repeal).*]. Effective 30 days after filing with the publisher.
