**TITLE 842 INDIANA BOARD OF PHYSICAL THERAPY**

**Notice of Public Comment Period for Rule Readoption**

LSA Document #23-774

Readopts rules in anticipation of [IC 4-22-2.6](#), providing that an administrative rule adopted under [IC 4-22-2](#) expires January 1 of the fifth year after the year in which the rule takes effect unless the rule contains an earlier expiration date. Effective 30 days after filing with the publisher.

**SUMMARY OF FINDINGS UNDER [IC 4-22-2.6-4](#)**

All of the proposed readopted rules remain necessary and meet the standards set forth in [IC 4-22-2-19.5](#). The rules avoid duplicating standards found in state or federal law, are written for ease of comprehension for the entities subject to them, and have practicable enforcement.
