Letter of Findings: 01-20231724 Individual Income Tax For The Year 2019

HOLDING

Individual established that he was erroneously disallowed scholarship tax credits, which resulted in the Department assessing more tax than was due.

ISSUE

I. Individual Income Tax - Scholarship Credit.

Authority: IRC § 62; IC 6-3-1-3.5; IC 6-3-2-1; IC 6-3.1 et seq.; IC 6-3.1-30.5 et seq.; IC 6-3.1-30.5-7; IC 6-3.1-30.5-11; IC 6-8.1-5-1; Indiana Dept. of State Revenue v. Rent-A-Center East, Inc., 963 N.E.2d 463 (Ind. 2012); Lafayette Square Amoco, Inc. v. Indiana Dept. of State Revenue, 867 N.E.2d 289 (Ind. Tax Ct. 2007); Dept. of State Revenue v. Caterpillar, Inc., 15 N.E.3d 579 (Ind. 2014).

Taxpayer protests the Department's assessment of additional Indiana individual income tax.

STATEMENT OF FACTS

Taxpayer is an Indiana resident who regularly files Indiana individual income tax returns. In 2023, Taxpayer received a notice of proposed assessment from the Indiana Department of Revenue ("Department") indicating that his federal adjusted gross income was understated on his Indiana individual income tax return. Department assessed additional tax on the unreported portion of his income for the 2019 tax year. Taxpayer disagreed and filed a protest to that effect. A hearing was held, and this Letter of Findings results. Additional facts will be provided as necessary.

I. Individual Income Tax - Scholarship Tax Credit.

DISCUSSION

The Department determined that Taxpayer owed additional income tax after reviewing information related to his 2019 income tax return. Taxpayer disagreed and protested the assessment. In support of his protest, Taxpayer provided a copy of his Indiana individual income tax return, his federal record of account for the 2019 tax year, and letters from a qualified scholarship granting organization.

As a threshold issue, it is the Taxpayer's responsibility to establish that the existing tax assessment is incorrect. A proposed assessment is prima facie evidence that the Department's claim for the unpaid tax is valid. <u>IC 6-8.1-5-1</u>(c). The burden of proving that the proposed assessment is wrong rests with the person against whom the proposed assessment is made. *Id.* Consequently, a taxpayer must provide documentation explaining and supporting that the Department's position is wrong. *See Indiana Dept. of State Revenue v. Rent-A-Center East, Inc.*, 963 N.E.2d 463, 466 (Ind. 2012); *Lafayette Square Amoco, Inc. v. Indiana Dept. of State Revenue*, 867 N.E.2d 289, 292 (Ind. Tax Ct. 2007). Additionally, "[W]hen [courts] examine a statute that an agency is 'charged with enforcing. ..[courts] defer to the agency's reasonable interpretation of [the] statute even over an equally reasonable interpretation by another party." *Dept. of State Revenue v. Caterpillar, Inc.*, 15 N.E.3d 579, 583 (Ind. 2014).

Indiana imposes a tax "upon the adjusted gross income of every resident person, and on that part of the adjusted gross income derived from sources within Indiana of every nonresident person." <u>IC 6-3-2-1</u>. The starting point for determining Indiana income tax is the taxpayer's federal adjusted gross income ("FAGI") as defined in I.R.C. § 62,

which taxpayers are directed to enter on their Indiana return before making the modifications outlined in <u>IC 6-3-1-3.5</u>. In addition to modifications, Indiana law also provides tax credits within <u>IC 6-3.1</u> *et seq.* to reduce state income tax liability. One such credit is Indiana's School Scholarship Tax Credit, which is outlined under <u>IC 6-3.1-30.5</u> *et seq.*

IC 6-3.1-30.5-7(a) states:

A taxpayer that makes a contribution to a scholarship granting organization for use by the scholarship granting organization in a school scholarship program is entitled to a credit against the taxpayer's state tax liability in the taxable year in which the taxpayer makes the contribution.

Additionally, IC 6-3.1-30.5-11 provides:

To apply a credit against the taxpayer's state tax liability, a taxpayer must claim the credit on the taxpayer's annual state tax return or returns in the manner prescribed by the [D]epartment. The taxpayer shall submit to the [D]epartment the information that the [D]epartment determines is necessary for the [D]epartment to determine whether the taxpayer is eligible for the credit.

During the hearing, Taxpayer indicated that he closed out an investment account in the relevant tax year. He explained that he used a tax filing software system that year to file his taxes and that he attempted to link his investment account to the tax filing software system. However, the two did not ultimately link. Due to this, his income was understated on his Indiana individual income tax return. Taxpayer concedes that this was income subject to tax under <u>IC 6-3-2-1</u>. Taxpayer disagreed, however, with the Department's calculation of the proposed assessment, believing it to be overstated by approximately \$2,000 as a result of disallowed tax credits.

Upon review of the Department's records, Taxpayer claimed a \$2,000 tax credit under Indiana's School Scholarship Program for donations he made to a scholarship granting organization. Taxpayer provided additional documentation, including letters from the scholarship granting organization, which reflect that his donations qualified for the aforementioned tax credit and were made in tax year 2019. This credit was erroneously disallowed by the Department. Taxpayer's individual income tax return will be corrected to allow the Indiana's School Scholarship tax credit as originally claimed. Taxpayer is still liable for the remaining assessment based on the discrepancy in his adjusted gross income.

FINDING

Taxpayer's protest is sustained to the extent described above.
