

**Readopted Final Rule**  
LSA Document #23-829

**DIGEST**

Readopts rules in anticipation of [IC 4-22-2.6](#), providing that an administrative rule adopted under [IC 4-22-2](#) expires January 1 of the fifth year after the year in which the rule takes effect unless the rule contains an earlier expiration date. Effective 30 days after filing with the publisher.

**SUMMARY/RESPONSE TO COMMENTS**

The Indiana Real Estate Commission (commission) requested public comment from February 14, 2024, through March 15, 2024. The commission received no comments in response to the Notice of Public Comment Period for Rule Readoption. [876 IAC 3-3-13.2](#) is repealed due to being outdated and in conflict with other rules.
