(C) was constructed without a department license required under $\underline{\text{IC } 14-26-2}$ (or, before their repeals, under $\underline{\text{IC } 13-2-11}$ or $\underline{\text{IC } 13-2-11.1}$).

- (4) The destruction of terrestrial vegetation.
- (5) The presence of litter or debris.
